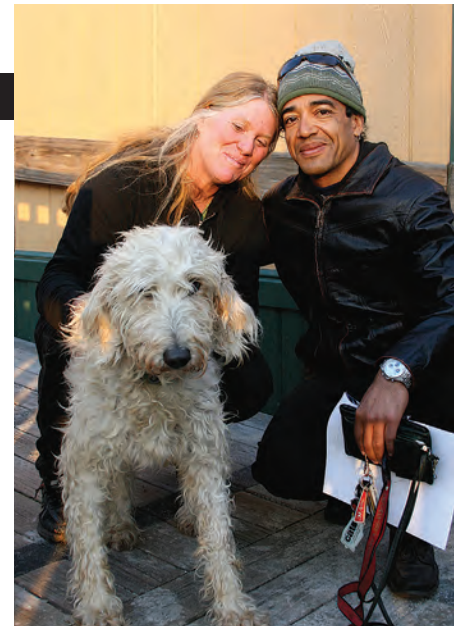
Support the Shelter Pet Medical Program

### **YOUR IMPACT: SPAY / NEUTER**

Support the Shelter Spay/Neuter Program  
Your gift will provide low-income pet-owners with access to spay/neuter surgeries and core vaccines for their pets. This prevention program also decreases animal shelter euthanasia by decreasing the number of animals ever entering the shelter system.

**This low-cost spay/neuter program has provided over 51,445 surgeries.** County-wide shelter euthanasia has been reduced by **75% over the last decade.** The downward trend began in 2010 after the first full year of the spay/neuter clinic operation.
